INITIAL

1. **PACKING, LOADING AND UNLOADING:** Customer is responsible for all packing of goods for transit including loading and unloading. It is the sole responsibility of customer to pack all personal effects using proper containers and protective padding supplied by the customer. Customer is responsible for installing the bulkhead, an AKA supplied wall that acts as a separator between customer's goods and other cargo on the trailer.
2. **PAYMENT TERMS:** AKA will accept payment with Certified Cheque, Cash or Money Order. Additional charges for services provided at destination will be collected upon arrival. Shipment will not be released at destination until payment in full has been made.
3. **LIMITED CARGO LIABILITY:** In exchange for AKA's lower rates, customer agrees that AKA's liability is limited to \$0.10 per pound per piece. Additional coverage is available and can be purchased at a higher price by contacting AKA prior to your move. Since the customer is responsible for the loading and unloading of the goods, the liability coverage only applies to the extent of negligence. Negligence is defined as any act or default of the carrier. The standard coverage or any additional coverage purchased is liability coverage for carrier negligence, not insurance for your goods. In the event of cargo damage caused by trailer fire, vehicle collision, vehicle overturn or complete trailer theft, AKA includes coverage of \$0.50 per pound per piece with a maximum liability of \$5,000 per trailer. AKA does not provide insurance for your goods. AKA assumes the liability of a common carrier, subject to provisions.
4. **EQUIPMENT DETENTION FEES:** If a customer is unable to take immediate delivery of the shipment, AKA will hold the shipment at the destination terminal. All days that shipment is held will be subject to detention fees of \$50 per day per trailer. Customer is given 2 business days at the origin and destination to load/unload the trailer. If customer exceeds this allotted time of 2 business days a fee of \$50.00 per day per trailer will be assessed. In situations of a "live load/unload" when arranged between AKA and customer additional fees will apply if customer exceeds the allotted time for the "live load/unload".
5. **OPTIONAL EQUIPMENT:** If a ramp is reserved at the origin and/or destination, the ramp will be delivered with the AKA trailer. The maximum weight limit for the ramp is 1,000 pounds. This ramp will be available for use for a maximum of 2 business days unless otherwise specified. Customer is responsible for contacting AKA when loading and/or unloading is complete. The ramp must be loaded outside on the trailer loading rack only. Additional charges of up to \$1000 will be applicable if the ramp is not returned to AKA in the same condition that it was presented. Ramp availability at origin is determined at time of reservation. Ramp availability at destination is determined at time of reservation.
6. **ADDITIONAL CHARGES:** The charges herein are based on the specifics outlined within this Bill of Lading. The charges are subject to change upon alteration of this schedule, including but not limited to: A) Change in spot date; B) Change in origin or destination city/postal code; C) Parking fees, fines or trailer tow; D) Equipment detention fees; E) Untimely return of ramp to AKA; F) Gypsy Moth quarantine (California); G) Canadian/US Customs delay; H) Cancellation within one week of move is \$50 or \$150 on day of move; I) Re-delivery charges of \$150 per re-delivery attempt per trailer; J) Trash or boxes left on trailer; K) Guaranteed Service.
7. **TRAILER PARKING:** A 40 foot commercial trailer will be spotted at customer's sole risk at the origin location and date shown herein. It is customer's responsibility to obtain permission for the placement of the trailer at the origin location for loading and at the destination location for unloading. Customer will be responsible for any subsequent parking charges for violations.
8. **HAZARDOUS MATERIALS AND COMMODITIES OTHER THAN HOUSEHOLD GOODS:** Customer agrees not to include hazardous materials of any type (including but not limited to petroleum products, compressed gases, corrosives, explosives and flammables) in the shipment. Empty propane containers may be included if properly purged. Hazardous material violations could result in additional charges resulting from local, provincial/state, and federal fines, as well as but not limited to, loss or damage to property and associated personal injury. In addition, shipments containing commodities other than household goods, whether disclosed or undisclosed to the carrier, are subject to provincial/state and federal over the road weight limits. If total shipment weight exceeds 22,500 lbs or causes trailer to exceed the legal limit on any axle, additional fees will apply.
9. **LIABILITY:** Customer agrees to hold AKA harmless and to indemnify it against any and all claims for loss, expense, liability or damage arising out of or in connection with the performance by customer, its agents or contractors of this price quote. AKA shall not be liable and hereby disclaims responsibility for any indirect, incidental or consequential damages or other indirect costs, fees or any charges of any kind arising from any claims filed hereunder, whether disclosed or not. If the shipment is arranged by a third party, other than the owner of the goods, the carrier will attempt to honor delivery requests made by the third party. Its failure to delay delivery, though requested by a third party.
10. **ASSUMPTION OF RISK:** Customer assumes all risks and liability arising from the use and operation of EQUIPMENT included with the package of services rendered and understands that such EQUIPMENT can cause injury or death to customer or others. Customer assumes full responsibility for damage, loss or destruction of the EQUIPMENT used by customer as part of the package of services rendered. Customer assumes full responsibility for and agrees to indemnify, defend and hold harmless AKA from any and all loss, liability, damage and expense in connection with the use or operation of such EQUIPMENT.
11. **NO WARRANTY:** AKA DOES NOT MAKE, HAS NOT MADE, NOR SHALL BE DEEMED TO MAKE OR HAVE MADE, ANY WARRANTY OR REPRESENTATION, EITHER EXPRESS OR IMPLIED, WRITTEN OR ORAL, WITH RESPECT TO THE EQUIPMENT PROVIDED HEREUNDER OR ANY COMPONENT THEREOF, INCLUDING WITHOUT LIMITATION, ANY WARRANTY TO DESIGN, COMPLIANCE WITH SPECIFICATIONS, QUALITY OF MATERIALS OR WORKMANSHIP, MERCHANT ABILITY, FITNESS FOR ANY PURPOSE, USE, OPERATION OR SAFETY. ALL RISKS ARE TO BE BORNE BY CUSTOMER. WITHOUT LIMITING THE FOREGOING, AKA SHALL HAVE NO RESPONSIBILITY OR LIABILITY TO CUSTOMER OR ANY OTHER PERSON WITH RESPECT TO THE FOLLOWING, REGARDLESS OF ANY NEGLIGENCE OF AKA; (I) ANY LIABILITY, LOSS OR DAMAGE CAUSED OR ALLEGED TO BE CAUSED DIRECTLY OR INDIRECTLY BY ANY EQUIPMENT, ANY INADEQUANCY THEREOF ANY DEFICIENCY OR DEFECT (LATENT OR OTHERWISE) THEREWITH; OR (II) THE USE, OPERATION OR PERFORMANCE OR ANY EQUIPMENT OR ANY RISKS RELATING THERETO.
